Meghan's Musings

It's the Most Wonderful Time of the Year!

I doubt anyone has ever re-written the lyrics to "It's the Most Wonderful Time of the Year" for Lent. (Though now that I think about it, I just might...) There are probably not too many people other than a few odd clergy who would declare "I love Lent!" But I just realized this year that I actually do. (Of course, I am an odd clergy person.) It's really true. I really do love Lent. Why?

I love Lent because it is a time for reflection, contemplation, self-examination. I love Lent because it's an opportunity to identify a behavior, practice or habit in our lives that by doing (or not doing) creates a barrier between us and our true selves, the image of God in which we were created, a chance to identify that barrier and work to remove it. And whether we choose to give something up or take something on, the Lenten discipline should be more than a re-boot of our failed New Year's resolutions. A meaningful Lenten discipline will be one with some theological significance, some way that you can explain to yourself—perhaps only yourself—that this will draw you closer to God.

I don't subscribe to the notion that a Lenten discipline should be painful or that our giving up something in any way gives us a taste of Jesus's suffering on the cross. Is going 40 days without M&Ms really going to give anyone a sense of Jesus's suffering? I don't think so. However, if you find that your affinity for M&Ms is somehow interfering with your journey with Christ—if you're obsessed with M&M's to the point that you can't think about anything else until/unless you get your M&M fix, or if you're eating enough M&Ms to negatively impact your health or if you find you value your time with your M&Ms more than relationships with loved ones—perhaps going without for a few weeks would be beneficial for you.

A few years ago I was watching a shameful amount of reality TV. If it was on Bravo, I was watching. I was not proud of this habit (it was a guilty pleasure with much more emphasis on the guilt than the pleasure) but it was just so hard to quit. (I mean, I had to find out how Bethenny was going put Jill in her place.) But I knew that reality TV was interfering with my reality. I knew that if I were to make a list of my priorities, reality TV would not be anywhere on that list. So, I gave up reality TV for Lent. I'm not going to lie. That first week or so was rough. I really wanted to know how the scandals of the previous week would be resolved, resumed or rehashed. I missed the opportunity to cheer for my favorites and jeer for the villains (or those who the producers of the show had manipulated footage to make appear as villains). But after a while, I began to appreciate all the extra time on my hands for my true priorities and for the real people in my life. I'm happy to say, by the time Easter rolled around, I had no desire to return to the Real Housewives of any city.

By the time you read this article, we'll already be well into Lent and that might lead you to think, "Oh well, too late to start a Lenten discipline now!" Well guess what? It's not too late! It's never too late to hit the "reset" button, remove barriers, re-align ourselves with God and reap the spiritual benefits of doing so.

Budget and Finance Corner

Pledges for the month of January were \$32,333.60. This was \$334 above budget for the month. Of this amount, \$16,569 had been prepaid in 2014, but transferred into 2015 as pledge income. We did not have any donations in this category this month.

Both the General Assembly mission payment (\$4,894) and the per capita payment (\$9,240) were remitted to Presbytery in January. In total for the month, expenses were \$572 under budget.

The Muñoces committee received donations of \$1,980 for future work in Berlin. During December, we collected an additional \$500 for the Christmas Joy offering and an additional \$500 for the Rural Harvest Offerings. These special offerings were remitted to Presbytery in January.

Work Week Update by Mickey Van Baale

The decision has been made and our 2015 Work Week trip will be to Kemmerer Village in Assumption, III. We will be leaving early the morning of July 5 so we arrive at our location in time to attend their church service, which begins at 2 pm. We will return on Saturday, July 11 and conduct the worship service on Sunday, July 12. Kemmerer Village is a private, non-profit human service agency established in 1914. Guided by the vision of their founder, Philip B. Kemmerer, their mission is to support families and children who face stress and turmoil in their lives. The primary program is residential treatment for adolescents.

Tasks that have been done by work groups in the past and would be a possibility for us are painting in cottages, trimming bushes, scraping pasture fence, trimming pasture fence, window washing, weeding flower beds, putting siding on cottages, putting roofing on cottages, replacing fence as needed around campus, hanging new gutters and putting up drywall. They also have an equestrian program as part of the therapy for the residents. Normally work groups are not allowed to work with the horses, but we may be the exception.

We held our informational meeting following worship on Sunday, February 15.

February Presbytery Report

The 499th meeting of Des Moines Presbytery was held at the Winterset First United Presbyterian Church on Saturday, February 14, 2015. In attendance from First Presbyterian, Newton, were Linda Anderson, Mickey Van Baale (non-voting members), Rev. Meghan Davis and Commissioner Linda Kirchhoff (voting members.) The session began with a worship service which was followed by a business meeting.

Many reports were given. Most are in printed form, and church members are welcome to view them. Mickey Van Baale reported on the Reconciliation Task Force, of which she is a member. Participants applauded after she announced that Wendell and Loretta Wendt, who had been Faithful Through the Years Honorees, were celebrating their 100th birthdays that day. Katherine Pater also gave an oral report on her work in El Salvador.

The major business items of the meeting concerned the Cottage Grove Presbyterian Mission Center and sale of the Presbytery office, six changes to the Book of Order by omnibus motion, the Belhar Confession, and Amendment 14-F on marriage.

The Budget and Finance Committee asked that \$100,000 (the projected amount from the sale of the Presbytery office which will be moved to Cottage Grove Mission Center) be changed to unrestricted funds from the Knox Knolls Camping Fund. This money would be used as a cash advance and returned to the Presbytery operating fund. After discussion and amendments, a motion was passed to return the money to the Knox Knolls Camping Fund instead.

There was also a presentation regarding the architect's plan for the center. It features a worship space, office space (for Presbytery, Cross Ministries, and non-profit rentals,) bathrooms, and a 3 story elevator. Estimated cost was \$2 million. The presenter felt confident the money could be raised through grants and donations, plus the sale of the office.

FYI

Amendments to the Book of Order and Book of Confessions. Amendments passed by members of the General Assembly are sent to presbyteries for approval or disapproval. Presbyteries transmit their votes no later than one year following adjournment of the GA. If the Stated Clerk receives written notice that the affirmative votes of a majority all the presbyteries has been received, the amendment becomes effective one year following adjournment of the assembly.

Following Roberts Rules of Order, at Presbytery meetings speakers can orally voice comments, alternating pro and con on the issue before a vote is taken. The vote can be voice or paper ballot. Proxy votes are not allowed.

Amendment 14-1: Confession of Belhar.

*The Bills and Overtures Task Force recommended that the Confession of Belhar be accepted in the Book of Confession. Following much discussion on both sides of the issue, the motion passed on a voice vote. (This is the first Confession sent to Presbyteries that was written by persons from the Southern Hemisphere.)

Amendment 14-F: Amending W-4.9000 wording on Marriage. Proposed Amendment to the PCUSA Book of Order by 2014 GA. {Background: The 2014 General Assembly agreed to grant pastors discretion in determining whether or not to conduct same-gender marriages in civil jurisdictions where such marriages are legal. The action effectively removed the ban on Presbyterian pastors marrying same-gender couples in those jurisdictions.}

The Bills and Overtures Task Force recommended that Amendment 14-F be accepted in the Book of Order. In brief, if a couple - traditionally a man and a woman- meets the requirements of the civil jurisdiction in which Continued on page 9

Warren and Linda Erickson were the first to leave on February 21 to work as international election observers for the El Salvador election on March 1. Kimberly Schnell will travel the day after the election and will meet Linda and Warren to travel together to Berlin to visit Muñoces for three days (March 5,6, and 7) on behalf of our congregation. Linda and Warren will fly home on March 10, leaving Kimberly in Berlin to teach English at Centro Escolar Amigos de Iowa. Doug Smith and his daughter, Jessie, will join Kimberly in Berlin on March 13 to help with her teaching. They also hope to visit the home of a new friend from Pella, Jose Carballo, who grew up in Las Delicias...one of the many cantons around Berlin, as well as the physical therapy clinic where Kimberly once volunteered. They will return together March 21 but may run into Tom Mott before they leave because he will be in Berlin March 15 - 22 fitting glasses with the medical delegation which began years ago at our own First Presbyterian and is now continued by the Catholics. All those traveling to El Salvador this spring were commissioned at the church service on Sunday, February 15.

2015 marks the 20th anniversary of the first delegation from this church to El Salvador. That delegation was charged with learning about the needs of the people who live in the cantons that surround Berlin, El Salvador and to work with a group of Salvadorans who were already working to improve the lives of the poor in that area. Twenty years later the ministry continues. The work has grown and changed through the years but the fundamental goals remain the same. Many of you have visited this area of El Salvador during the last 20 years and many more of you have shared your resources to make this ministry possible. Thank you to all! We will create an opportunity for all of you to hear more about our travels after everyone has returned.

The components of the latrines have arrived in Muñoces and pictures are on the bulletin board in fellowship hall. Also, on the last afternoon that Ericksons and Kimberly Schnell are in Muñoces, they will hold a fiesta, which has become a yearly tradition. This normally consists of having a piñata and light snacks.

a teaching elder may - bu

they reside, a teaching elder may - but is not required to - perform a marriage ceremony. The teaching elder may seek the counsel of session, which has the authority to permit or deny the use of church property for such a ceremony. Following a great, great deal of discussion and debate, the motion passed by a paper ballot vote.

The date for the next Presbytery meeting will be changed to June 6, 2015. The meeting will be a joint meeting with the Presbytery of North Central lowa and will be held at Collegiate Presbyterian Church in Ames. This will be the first time the two presbyteries have met together for worship and will be the 500th meeting of the Des Moines Presbytery. They will separate to conduct business.

The meeting closed with singing and prayer.
