


Just Eating? Practicing Our Faith at the Table Wednesdays. in Lent 5:30-6:45 beginning March 6

Carol Jean Soderblom Hammer died December 29, 2018. She was born on January 27, 1929 in Newton, Iowa, the only child to parents Mabel and John Soderblom. Carol attended Newton Public Schools graduating in 1947. After earning a Master's degree in music education and piano performance and in the 1960's, during which time she played violin with the Central College Orchestra and substituted in the orchestra at Iowa State University in Ames, Iowa. Beginning in 1968 she did further graduate work in piano pedagogy at Columbia University in New

York City, and taught piano at the renowned Harlem School of the Arts. In 1970 she returned to Iowa and started a classic piano program in the Des Moines Public Schools. From there she went to the University of Iowa and earned a PhD in Music and Music Education. It was while working on her doctorate at U of I that she met her future husband, Carroll Proctor, who was working on his doctorate in Musicology. Both Carol and Carroll taught in the music department at Simpson College in Indianola, Iowa until their retirement. They were married in 1994 and upon retirement in 1995 moved to Newton Iowa, living in the family home built by Carol's father. There they opened a piano and voice studio, mentoring and teaching students from ages 5 to 85. Carol was involved in the Des Moines Metro Opera, PEO, Newton Book Club, First Presbyterian Church, Newton Concert Association, and coordinated and supported several cultural events in the Newton community. She was an avid reader, an accomplished seamstress and needle worker and was always elegantly styled in classic fashion. After Dr. Proctor's passing in 2010, Carol reconnected with childhood friend David Hammer. Carol and David were married August 12, 2013 on the RMS Queen Mary II in a ceremony performed by the captain of the ship. They honeymooned in Europe and lived in Dubuque, Iowa for 4 years before returning to Newton. Carol was preceded in death by both Carroll Proctor and David Hammer. She is survived by two step-children, Julie Hammer and David Hammer and 3 step-grandchildren. A service of music and celebration was held at 11:00 am Saturday, January 12, 2019 at our church. Interment followed at Newton Union Cemetery.

David L. Hammer, 89, of Dubuque and Newton, Iowa passed away Thursday, December 27, 2018. David was a lawyer, writer, world traveler, father, son, and husband. A service of remembrance was held Thursday January 10, 2019 at 11:00 am at the University of Dubuque, Blades Chapel. Burial will be in Honey Creek Friends Cemetery, New Providence, Iowa, with his family at a later date. He is survived by: his daughter Julie Rae Hammer, her former husband Paul Bly, and grandson Graham Bly all of Iowa City, Iowa; his son, David Lindley Hammer, daughter-in-law Mary (Brown) Hammer, and grandsons Maxwell and Samuel Hammer all of Denver, Colorado. He was preceded in death by others very dear to him: his parents, Neal and Agnes Hammer of Newton, Iowa; his first wife, Audrey Anna Hammer; and his daughter, Lisa Agnes Hammer.

The committee met Jan. 8. During discussion of recent worship services, the following were noted:

The purpose of the Mission Committee is to recommend, approve, manage, and terminate mission projects. The committee communicates about opportunities for mission involvement and promotes congregational participation.

Days for Girls. Newton IA Days for Girls Team workshops continue. Our first workshop for 2019 was held Thursday, January 24 from 9 am – 2 pm. AND a new evening session from 6 – 9 pm in fellowship hall. Our February workshop will be Thursday, February 28 with the same times as above. Sewing and serging, ironing and cutting fabric plus other tasks are involved in creating the sustainable feminine hygiene kits that allow girls to continue their schooling. Please come and see how these kits are made; stay if you would like to help with this very worthwhile project!

Ramp Building Project First Presbyterian Church began a ramp building ministry in 2017 in partnership with Kid Assist of Jasper County which uses Friendship House as its main office. We built two ramps in 2017 with funds raised from proceeds of the June 2017 Ice Cream Social. We also repaired the ramp at Friendship House that summer.

In 2018, we had no requests for accessible ramps until October. Since then, we have had seven requests for ramps. In two of those situations, we determined that a ramp would not meet the need. We will fulfill two of the other requests with portable heavy metal tri-fold ramps, one 7 foot ramp and one 10 foot ramp which Kid Assist has purchased and will be a part of their inventory as they can be moved and used at other settings.

Since we are now in the middle of winter with snow on the ground and more predicted to fall, it is uncertain when we will be able to fulfill the three remaining requests for ramps. We will need to raise more money in order to be able to fund the building of three wooden ramps. We do have some wood and materials left from our previous builds and will be able to use that.

Operating Revenue and Expenses for the 4th quarter 2018 ... October through December

- ◇ Pledges for the quarter were \$35,702. This was \$5,837 above budget for the quarter.
- ◇ Other Regular Giving, which represents donations from people who give, but do not pledge, was \$3,177 for the quarter, which was \$1,968 above budget.
- ◇ We recorded a \$4,532 unrealized investment loss for the quarter.

Other Income for the quarter:

- ◇ A \$395 donation was received to go toward outside sign repairs.
- ◇ Received \$94 donation for per capita.
- ◇ We received an additional \$4,330 in prepaid 2019 pledges bringing our total to \$11,150. These will be transferred to Pledge Income in 2019.
- ◇ The Yoga fund received donations of \$905.
- ◇ The Deacon fund received donations of \$143.09.
- ◇ The Designated Mission fund received the Christmas Joy offering (\$430), Rural Harvest offering (\$530) and Cents-Ability donations (\$246.28).
- ◇ In addition to the \$130 collected in September, the International Mission account received \$545 for Crop Walk and a \$100 donation for Days for Girls.

Expenses for the quarter:

- ◇ The balances in the Capital Development Maintenance Fund, the Kitchen Remodel Fund, and the majority of the Funeral Luncheon and Sundays at 4 Funds were all combined with the Memorial Fund. The new fund was renamed the Memorial/Improvement fund. Both the Funeral Luncheon and Sundays at 4 Funds were left with a remaining balance of \$500 each to cover future needs.
 - ◇ The Memorial/Improvement Fund received \$3,850 from the Foundation investment earnings. A roof repair expense in the amount of \$4,805 was paid out of this fund.
 - ◇ The Yoga fund paid \$623.94 to reimburse Meghan for yoga expenses she had previously paid.
 - ◇ The Deacons made contributions to the Salvation Army (\$400), Impact (\$150), and reimbursed Meghan (\$122.85) for expenses for the college care packages.
 - ◇ The Designated Mission fund made contributions to the Salvation Army (\$100) and Presbytery of Des Moines for hunger programs (\$100).
 - ◇ The International Mission account paid \$269.86 for Days for Girls expenses and remitted the Crop Walk donations.
 - ◇ The Undesignated Mission fund made a contribution to Bread for the World (\$150).
- In total for the quarter, expenses were \$871 below budget.

Year-to-date through December:

- ◇ Year-to-date, pledges are \$34,962 over budget. This includes two one-time gifts of \$10,000 each, as well as increased pledges.
- ◇ Other Regular Giving is \$5,062 over budget.
- ◇ Investment Income was \$9,333 below budget due to market value declines.
- ◇ We budgeted to collect half of our per capita expense from members, but these collections were \$1,127 below budget.
- ◇ Expenses are \$4,489 over budget.
- ◇ For the year, our operating expenses exceeded our income by \$2,483.
